- (1) Expenditures and Other Financing Uses for the General Fund, Special Revenue Funds, Debt Service Fund (prior to FY 2000 when fund was closed) and the School Board component unit, excluding the School Construction Fund and School Print Shop Fund, are included in this schedule.
 - (2) Transfers Out between the fund types represented in this table have been subtracted to obtain net transfers out, thus eliminating the duplication of expenditures. Payments to the Risk Management and Insurance Fund have been reclassified in 1996 from transfers out to internal service charges because of the reclassification of the Risk Management and Insurance Fund to an internal service fund.
 - (3) Education expenditures for years prior to 2002 included transfers to the Schools for sales and use tax. Beginning in fiscal year 2002, these funds are received directly by the Schools. The amount of sales and use tax included in education expenditures in 2001 was \$11,673,849.
 - (4) Public Works expenditures decreased in FY 2003 due to the creation of the Waste Management Fund.
